Entries Closing Date :: **Sunday, 25th DECEMBER 2022**

Entries shall not be accepted without CGBA ID.

The Entries shall be received by CGBA as per the existing system with a copy to Org. Secretary. The entries are to be received through Affiliated Units only at entry.cgba@gmail.com. (Direct entries from the Players are not valid).

Entries shall be sent in the following format. Preferably in excel format.

Doubles Entry :: Districts forwarding names for Doubles Partnering player from different districts should have NOC or otherwise names of same pair should come from both the districts failing which the entry will not be considered and the entry Fee will be forfeited.

Entry Fee :: **The entry fees that for qualifying participants shall be as follows.**

Singles event of all categories: Rs. 500/-

Doubles event of all categories: Rs. 1000/-

The host organizers shall be responsible for collection of entry fee from the players.

Registration Fee :: The registration fee is mandatory for all the players once in every year.

Registration Fee is Rs.200/- per player ONCE IN A YEAR

Mode of Competition :: All the matches shall be played best of three games of 21 points on a rally point system. However if the number of entries are more than expectation, the Referee in consultation with the Organizing Committee and the Observer, CGBA may take the decision to conduct the matches in best of

Three (3) games of 15 points each with extension of 21 points.

Regulations :: The BAI competition regulations & General competition regulations shall be applicable.

Clothing Regulations :: Players must comply with General competition regulations.

M&Q :: **Player's entry list will be published on Dated 27th December 2022 in CGBA website. (www.cgba.co.in)**
At the close of entries, the Tournament Planner will provide the list of Participants. The list of participants in order of strength will be displayed on CGBA website. It shall be the responsibility of the Affiliated Unit and the players to ensure that all the entries forwarded by the affiliated units appear in the list. No complaints shall be entertained for miss out of any entry. CGBA will not be responsible for any omissions of names. After close of entries additional entries are not permitted.

Withdrawals :: **28th December 2022**
If there are any withdrawals after the close of entries, it shall be intimated to CGBA immediately by the Affiliated Units/ player before the closing date of withdrawal. Any player failing to participate in any CGBA approved tournaments after draw is made is liable to pay Rs. 500/- for each event (Rs. five hundred only) fine to CGBA before participating in next tournament. No exemption under any grounds (including medical) will be allowed in payment of fine. No player is permitted to Participation the next tournament without paying fine.
Referee shall submit the withdrawal list to CGBA within 24 hours after Completion of the tournament. On receipt of the list Member Associations concerned shall collect the fine amount and forward to the Associations concerned.

Draw :: Draw will be made on **30th December 2022**

Protest :: The fees for lodging protest of any kind shall be Rs. 500/-. This fee shall be retained by the organizers of the event. Any protest shall be addressed to the Hon. Secretary, CGBA in writing within one hour after completion of the match or 04 hours before commencement of the match.

Disciplinary Committee :: A disciplinary committee consisting of three members is deployed by CGBA to look after the behavior of players on court as well as off court. The Committee members are:

Disciplinary actions ::
a) Level 01 offence: Fine of Rs. 500/- to Rs. 1000/- will be imposed.
b) Level 02 Offence: Fine of Rs. 2000/- &/OR Disqualified from tournament
c) Level 03 Offence: Fine of Rs.3000/- &/OR debar from CGBA for 6 month to 03 years & player cannot participate in any National tournament of BAI.

Technical Officials ::
The Court Officials shall be nominated by CGBA.
Referee : 01
Dy. Referee / Match Control : 01
Umpire : 06
In addition to the Referee(s) nominated above, the Host Organizers shall nominate one Table official, one Announcer & one media relation officer with required line judges (minimum 04 per court) to assist the Referee during tournament.

Other Points ::
a) The players have to make their own arrangement of lodging & boarding.
b) Breakfast, Lunch and Dinner will be provided to all players by the Host Association free of cost.
c) All the Technical Officials will be provided free lodging, boarding and transportation facilities along with officiating allowances by the host association as per the rule of CGBA. (Annex-A)
d) Observer/Officials nominated by CGBA shall entitle for TA / DA as per CGBA rules. (Annex-B)
e) One player shall participate in only three events (01 Singles, 01 Doubles & 01 Mix Doubles).
f) Minimum 06 entries are required to provide Merit certificate to the players in that particular event.
g) Minimum 02 entries are required to conduct the event.
